 - Tolis-boys' sports are booming; younger boys are playing and

- Boys USAV fallout; more stable USAV schedule on home front targeting lower level teams; Region used to run the Christmas tournament- got girls and boys in the same gym; continue to offer and give back and support the boys

7. Officials (Dean)

- Cautious of adding more tournaments due to less officials;

- Recruitment efforts in region need to target younger demographic

B. Chairman (Tolis) – Agenda Planning

a. Budget Review

- Looks like we did agree to certain amount for boys/girls; expenses went up but Dan did call to let Tolis know
- Still operating in black without WCNQ

b. Any cost saving measures we can take?

- Were operating more ‘fiscally cautious’ this year; adidas vik is higher and sponsoring region

c. Outlook for 2022-2023 club season.

- Schedule is full, have CRQ, WCPL, WCNQ, 18’s

d. Discussion regarding Summer Tryouts (Boys & Girls).

- Starting (Saturday) July 15th to keep consistency
- OR July 22/23 gives more times for the ~30% to the kids that will jump clubs
- Clubs against JVA clubs & bordering regions
 - Earlier summer tryouts try to help retain members; but looks like money grab
 - Helps families spread out payments
 - Why rush earlier tryouts when
- Tryouts July 15th (add verbiage-second Saturday after last date of USAV nationals)
 - Motion-Summer of 2023 Tryout date:
 - Ryan: 1st Allowable girls tryout date will be second Saturday after final date of USAV nationals (with impending possible dates i.e. Illinois dead date, etc.)
 - Mary seconds; 11-0-0

D. Membership Value (Dan)

1. Education= AOC and new USAV platform
2. Working with Lexus Toyota for naming rights and get GLR members a discount

E. All-Star Championships (Dan)

1. Social media coverage by grad assistants, medaled in $\frac{3}{4}$ teams. Forfeited bronze medal match and sent 2 players home. Had all collegiate coaches. Went over budget by \$7k, prior to return flights being refunded.
2. Implement rules regarding participation, change tryout process
 - Can non-GLR players participate?
 - Run a camp series at collegiate campus (bid out to collegiate campuses), charge \$400-\$500 for 4–5-day camp
 - Tryout for camp, camp is pre-req tryout for final team
 - Why should clubs who are not loyal to GLR/USAV be

allowed to reap region member club benefits

- Possibility, if you're not in a GLR member club, pay \$\$
- Dean would like to motion to fund All Star program as was in 2022
 - Funding \$31.5k; then charge GLR members for camp
 - \$20/tryout, then TBD (\$300-\$400)
 - Seconded by Bob Jones (?)
 - 10-1-0 passes

F. Recruitment

- a. Coaches recruited by other clubs. What is our obligation via the GLR?
 - i. Recommend advising of best-practice and clubs to issue non-competes with their staff, especially those that they may have concerns.
 - Club issue. GLR shouldn't touch. Clubs need to know what being an employee vs. IC and have non-competes possibility.
- b. "Tuition waivers" offered to student-athletes by clubs (Tolis)
 - i. What is our obligation to notify appropriate authorities when this takes place?
 - ii. What if not USAV, still raises concerns with the NCAA.
 - NCAA and IHSA violation
 - Sub-committee formed by Miguel, Terri and Sue to join
