IV. MINUTES

The minutes from our last meeting, of May 7th, 2023, were previously forwarded to you for review and passed unanimously.

V. OLD BUSINESS

- Commissioner Review – completed in August 2023
 - Conducted by Tolis (Chair), Sue Keck (Girls Rep), and Dean Hoskin (Officials Rep)
 - Our evaluation was sent to the BOD for review.

VI. NEW BUSINESS

A. REPORTS

1. Commissioner (Dan)

- GLR teams have done well at adult and girls nationals, will continue supplying.
- WCPL 566 teams, BRC ahead of last year, 18's qualifier almost full, WCNQ moved to waiting list.
- Officials are trending upward with amount of people that want to pursue officiating and junior officials want to continue and more training sessions will continue.
- Recommended to us by Dave Lockwood (gentleman that helped re-write GLR By-Laws) that WCPL committee should be have a representative as one of the girls' positions should be a rep from the WCPL Committee.
- Combines prior to both qualifiers, hoping for a possible adult tournament night before G18s as well.
- Logo sponsorship full rollout for 2024, waiting on USAV approval but

will honor any clubs that took advantage of that this season.

- Nationals' assistance will start back up per auditor; additional recommendation to invest in facility with court space.
- Building relationships with former local Olympians.

2. Treasurer (Charlie)

- Increased revenue and reserved.
- Audit is underway, all seems well currently.
- CDs are working well for us for this year.
- Charlie is in process of consolidating quickbooks.

3. Region Services (Kim)

- Membership is trending in the right direction; up 16% from last year at this time-whether it's due to SE registration opening up earlier or clubs registering more members.

4. Girls Reps (Ryan, Sue, Terri, Mike)

- Growth amongst many of our clubs; clubs are getting used to summer tryouts. Ryan's email responses regarding club retention period, recruiting and stopping late transfers prior to USAV sanctioned event.

5. Boys Reps (Tolis, Miguel)

- Interest from boys' side to start a Power League similar to WCPL.

6. Officials (Darren)

- Officials less professional than in the past; would love to see improvement.

7. Adults (Bob)

- Not a lot of change. Region looking for opportunities for growth. College officiating memberships could help drive adult open participation.

8. Outdoor (Lorelee)

- Went well, Partnered with Players Sport and Social and EVP (NW Indiana) to add to power league. Dave recommended 8/3 for the big championship. Outdoor grew 15% compared to last year.

9. Independents (Trish, Paul)

- Do we need authorization for nonprofit to sponsor another nonprofit?
 - Paul into executive session
 - IVCA is a state extension of AVCA; all awards are sponsored by GLR (representation at state, rep on awards)
 - Leave executive session

B. Chairman (Tolis) – Agenda Planning

- a. Budget Review/Audit
 - Possibility of hiring a consultant/strategic plan outside of the volleyball world.
- b. Any cost saving measures we can take?
 - Cost-saving measures: office rent; Charlie will provide detailed expense to BOD
- c. We still have an issue to settle in what is our investment aim with the resource now attained by the GLR.
 - GLR could pay for all adult background screens;
 - Sue would like to get it on the agenda for May agenda (~1850 members @ \$14/screen comes out to ~\$26k)
 - New officials startup costs is high

C. Officials (Darren)

- 1. More follow up with new officials or looking to get started

D. All-Star Championship Summary (Dan)

- 1. Giving kids collegiate experience during the tournament; Dan is requesting renewed commitment for next year.
 - Lorelee: Motion put forward to support the Great Lakes Region High Performance program, boys and girls, with a financial support of up to 50% of the total program cost for 2024-2025, with a limit of \$50,000 total.
 - Passed 7-1-0

E. Pre-Signing of Current Members (Kim & Tolis)

- a. Clubs have a right to pre-sign their own players, contractually to the following season, as determined by GLR policy. This can be done before the tryout date. A review of this policy could be necessary based off of member club's feedback.
 - a. Athletes and families feel pressured to pre-sign for playing time at nationals, etc.
 - b. May increase illegal recruiting at nationals.
 - c. No motion coming forward to table; no changes to policy.
 - d. Will be added to May agenda.
